Whereas a number of private unaided institutions offering different under-graduate/post graduate courses i.e. Degree Courses, B. Ed., M. Ed. and Engineering Courses are functioning in the State with due approval of the State Government and with due affiliation of the State Universities.

Whereas the existing unaided private institutions are being inspected by the nominated committees every year for the renewal of permission in terms of SRO-339 of 2005 dated 20-12-2005 (Jammu and Kashmir Private Colleges (Regulation and Control) Rules, 2005); whereafter the affiliating Universities also inspect the institutions for the requisites laid down under the statutes for academic and infrastructural adequacy.

Whereas, most institutions that have been given permission and affiliation have completed all the initial formalities for establishment/starting courses, acquired credibility of functioning and have commensurate infrastructure required as per the statutes/norms of the affiliating Universities.

Now, therefore, in view of the above, sanction is hereby accorded to the adoption of following slabs of duration for the grant of renewal of permission in favour of private un-aided institutions/colleges functioning in the State.

► The affiliating Universities shall ensure that all the requirements as laid down in their statutes for affiliation alongwith the removal of deficiencies are fulfilled by the concerned institutes as usual, before the affiliation is granted.
